## TERMS AND CONDITIONS

*The 'Receive SG\$28 Reward When You Open an MT5 Account with minimum USD\$2,000 deposit and make at least one trade' marketing campaign is organised by Orient Futures International (Singapore) and all references to 'promotion' shall refer to this campaign.*

### *Promotion Period*

1. The promotion period is from 1 - 28 February 2021 (both dates inclusive), or any other period(s) as reasonably determined by Orient Futures International (Singapore) Pte. Ltd. ("OFIS") in its absolute discretion (the "Promotion Period").

### *Eligibility*

2. This Promotion is applicable to the first fifty (50) new OFIS customers who open either an Individual account(s) or a Joint account(s) with OFIS. This is applicable only to MT5 trading account. New customers are defined as customers who are not existing customers.
3. A new customer who (i) is successfully onboarded with OFIS as a customer with an open and activated account, (ii) deposits a minimum quantum of US\$2,000 or equivalent in other currency (via OFIS' stipulated deposit

channel) into the relevant activated account, and (iii) makes a minimum of one (1) trade in any Forex product (minimum size of 1,000 units) on the MT5 trading platform shall be deemed to be an Eligible Customer for this promotion (“Eligible Customer”). All the above three conditions must be fulfilled during the Promotion Period.

4. Upon satisfying clauses 2 and 3, OFIS shall in its sole discretion determine and award an amount of SG\$28 or equivalent in other currency (the “Reward”) of trading credits to the first fifty (50) successful Customer accounts.
5. Each Eligible Customer is only entitled to receive a maximum of one Reward under this Promotion regardless of the number of accounts opened. Customers who open a Joint account shall be deemed as one (1) eligible customer for the purposes of this Promotion.

OFIS decision on all matters relating to this Promotion will be final and binding on all participants. No correspondence shall be entertained.
