- *The State Council said to insist dynamic zero policy unchanged with virus control measures optimized as its incubation, transmissibility and pathogenicity change.
- *Xinjiang province announced to stop managing close contacts for covid patients tested positive while have no symptoms and Ct value \geq 35.

Financials

*Ministry of Human Resource and 4 other departments jointly issued administrative method of personal pension fund which clarified specific rules on participation procedure, management, information disclosure and supervision. The maximum amount of subscription is cny 12k per participant and the pension fund account will be in close operation.

*Fang Xinghai, vice chairman of CSRC said to further facilitate cross-border investment and support development of cross-border financing with connect mechanism like GDR and CDR optimized. Legitimate overseas listing is support with related system reform to be implemented.

*Foreign minister of France said president Macron will visit China in future weeks or months, though spokesman of MoF said nothing can be disclosed yet.

*China Aviation Supplies Holding signed purchase contract with Airbus on 140 airplanes worth usd 17bn on Nov 4th.

- * Global crude oil price closed up collectively. December NYMEX contract up 5.02% to closed at \$92.60/b, January Brent contract up 4.21% to closed at \$98.66/b. INE crude oil active contract up 2.59% to closed at 718.1 yuan/b.
- * Precious metals closed up collectively. COMEX gold contract up 3.36% to closed at \$1685.7/oz. SHFE gold active contract up 0.85% to closed at 393.34 yuan/gram.
- * Metals closed up mostly, LME copper up 7.02%, LME zinc up 6.78%, LME tin up 6.27%, LME nickel up 4.37%, LME aluminum up 4.13%. SHFE tin up 6.26%, bonded copper up 4.82%, SHFE copper up 4.41%, SHFE zinc up 3.97%.
- * Commodity futures closed up collectively. Energy & chemistry futures saw strong performance, soda ash up 3.06%, PTA up 2.35%, TSR 20 up 2.18%, EB up 2.16%, fuel oil up 2.12%, LLPE up 1.6%.
