*Beijing Stock Exchange announced to half cut transaction handling fee from 0.5‰ to 0.25‰, to take effect from Dec 1st.

*PBoC and Ministry of Foreign Exchange announced fund administrative rule of foreign investors in investment of China bond market with fund account, payment, exchange and supervision under unified administration. Spot settlement and sale of exchanges, risk administration and currency matching to be optimized in encouraging long-term investment in China bond market.

*FTSE RUSSEL flagship index announced quarterly adjustment result and to include 4 HK listed names into its global stock index, including 9696, 2237, 2246 and 6667, which to take effect after market closing on Dec 2nd.

*Targeted elderly care deposit products may open for sale on Nov 21st with 5-year rate set at 4% in Xi'an, higher than fixed deposit rate of large banks, according to some bank managers.

* Global crude oil price closed down collectively. December NYMEX contract down 1.4% to closed at \$80.26/b, January Brent contract down 2.14% to closed at \$87.86/b. INE crude oil active contract down 3.53% to closed at 600.5 yuan/b.

* Precious metals closed down collectively. COMEX gold contract down 0.62% to closed at \$1752/oz. SHFE gold active contract down 0.68% to closed at 404.72 yuan/gram.

* Metals closed up mostly, LME nickel up 2.16%, LME zinc up 1.19%, LME aluminum up 1%. LME copper down 0.91% on the contrast. SHFE zinc up 0.86%, bonded copper down 1.22%, SHFE copper down 1.03%.

* Commodity futures closed down mostly. Energy & chemistry futures saw weak performance, fuel oil down 3.34%, bitumen down 2.39%, TSR 20 down 2.22%, natural rubber down 1.96%, LPG down 1.03%. Black series closed down collectively, coke down 1.79%. Agricultural products closed down mostly, rapeseed oil down 3.35%, cotton down 1.37%, soybean oil down 1.28%, No.2 soybeans down 1.01%.
