### **Commodities (night session):**

- \* Global crude oil price closed up mostly. December NYMEX contract up 0.17% to closed at \$80.25/b, January Brent contract up 0.11% to closed at \$87.72/b. INE crude oil active contract down 0.47% to closed at 597.4 yuan/b. NYMEX and Brent oil dropped over 6% in the night session due to message showed that Saudi Arabia and other OPEC members are considering higher the productivity by 500,000 b/d. The Saudi energy minister disproved the message later and oil price rebounded and closed with slight increase.
- \* Precious metals closed down collectively. COMEX gold contract down 0.85% to closed at \$1739.5/oz. SHFE gold active contract down 0.13% to closed at 404.74 yuan/gram.
- \* Metals closed down collectively, LME tin down 6.02%, LME zinc down 3.79%, LME copper down 2.24%, LME lead down 2.09%, LME aluminum down 2.06%. SHFE zinc down 2.77%, SHFE tin down 1.80%, bonded copper down 1.53%, SHFE copper down 1.31%.
- \* Commodity futures closed down mostly. Energy & chemistry futures saw weak performance, PTA down 2.97%, polyster staple fiber down 2.55%, fuel oil down 2.53%, bitumen down 2.36%, methanol down 2.3%, EB down 1.63%. Black series closed mixed, iron ore up 0.2%, coking coal down 0.86%. Agricultural products closed down mostly, rapeseed oil down 1.94%, soybean oil down 1.52%, RBD palm olein down 1.12%.
