#### Financials

\*SASAC: accumulated operation income realized by state-owned enterprises in 2022 of cny 39.4tn, up 8.3% y/y with total net profit of cny 1.9tn realized, up 5% y/y.

\*SASAC: new round of plan in deepening reform of state-owned firms is under formulation, aiming to improve core competitiveness of enterprises.

#### **Industrial Economy**

\*Vice premier Liu He emphasized on the Davos Summit that real estate is the pillar industry of China's national economy and will be strongly supported by giant demand potentials.

\*SASAC: China to consolidate stable growth and investment measures focusing on infrastructure construction with "channel computing resource from east to west" projects to be promoted in accelerated pace along with upgrade of information infrastructure.

\*MIIT and 5 other departments jointly issued opinions in promoting development of energy electronic industry with high purity silicon materials and large-sized silicon wafer tech to be developed and production of high-efficient low-cost silicon cells supported. Tech breakthrough of new-type energy storage batteries to be enhanced with scale application of advanced energy storage tech and products promoted. Besides, application of energy electronic products in new infrastructure fields, 5G base stations and NEV charging facilities to be improved.

\*XPeng announced to adjust sale price down by cny 20k to 36k respectively on different vehicle types.

\*Tesla, BYD and Hyundai are finalizing deals to invest in Indonesia's electric-vehicle industry in expected total investment of usd 30.9bn by 2026, said a senior minister.

\*Huawei plans to issue cny 3bn medium-term note in supplementary of operational funds at rate of 3.45% for 5 years and maturity date of Jan 16th 2028.

- \* Precious metals closed mixed. COMEX gold contract down 0.55% to closed at \$1911.2/oz. SHFE gold active contract up 0.05% to closed at 419.14 yuan/gram.
- \* Metals closed mixed. LME nickel down 2.36%, LME tin down 0.5%, LME copper up 2.09%. Bonded copper up 2.05%, SHFE copper up 1.95%, SHFE aluminum up 0.70%. SHFE nickel down 0.94%.
- \* Commodity futures closed up collectively. Energy & chemistry futures saw strong performance, fuel oil up 3.25%, LPG up 1.69%, polyester staple fiber up 1.67%, soda ash up 1.57%, glass up 1.44%, PVC up 1.38%.
