Financials

*Ministry of education and other four departments jointly issued "reform plan for adjustment and optimization of academic disciplines and specialties in general higher education" which pointed out to optimize and adjust 20% of academic disciplines in universities and set up a batch of specialties that adapt to new technologies, new industries and new forms of business, further increase the proportion of basic academic specialties especially in science and basic medical sciences.

*HKMA: At present, international investors mainly allocated rate securities with two-thirds of foreign fixed-income assets in China were concentrated in national debt. There is a large room for improvement in the allocation of debenture bonds. CMU will actively cooperate with mainland related departments to make technical preparations which facilitate foreign investors access to the mainland inter-bank and exchange bond markets through Hong Kong and further allocate debenture bonds, said by Yu Weiwen, head of Hong Kong Monetary Authority said in 2023 China financial forum annual conference.

*SAFE: Utilizing Generative AI to study financial problems may help form an effective technical route for financial development and governance, said by Lulei, head of SAFE in 2023 China financial forum annual conference on April 4th.

*MIIT: China lithium battery industry kept growth in Jan-Feb 2023, nationwide total output of lithium battery exceeded 102GWh, up 24% y/y, with energy storage battery output exceeded 15GWh and load capacity of power batteries for NEV of 38GWh. Export trade of lithium battery reached cny 70.6bn which grew steadily.

*National Energy Administration held conference in accelerating the integrated development of oil and gas exploration and new energy which pointed out that oil and gas exploration and development enterprises together with new energy and electric power enterprises to promote oil and gas production and supply, promote green low-carbon transition and high-quality development.

*CPCAAUTO: The retail sales of NEV reached 600k units on March, up 20% m/m and 30% y/y, the retail sales of NEV of 1.48mio units in Q1, up 25% y/y, as predicted.
