*The US Secretary of State Antony Blinken will visit China from June 18th to 19th.

Industrial Economy

*CAAM: The domestic automobile market is in a slow recovery stage and it is necessary for the country to continue to introduce measures to accelerate the release of consumption potential. *Ministry of Agriculture and Rural Affairs stated to continue to work with relevant departments to further increase support for the cultivation of leading enterprises and consortia in agricultural industrialization.

*NDRC: Ensure stable and orderly supply of energy and electricity during peak summer season.

Policy

*NDRC: Speed up the completion of the revision and repeal of regulatory and policy documents that are inconsistent with the requirements of the "regulations on optimizing business environment". It is strictly prohibited to generally suspend production and business without legal procedures and to prevent "one-size-fits-all" law enforcement.

*NDRC stated to study and introduce more policies and measures to attract foreign investment, reasonably reduce the negative list of foreign investment access.

*Ministry of Human Resources and Social Security issued to steadily implement the national coordinated and unified national fund revenue and expenditure management system for pension insurance.

* Global crude oil price moved down collectively. July NYMEX crude oil contract down 1.07% to closed at \$68.68/b, August Brent contract down 0.93% to closed at \$73.60/b. INE crude oil active contract down 0.85% to 514.5 yuan/b.

* Precious metals closed down collectively. COMEX gold contract down 0.15% to closed at \$1955.7/oz. SHFE gold active contract down 0.16% to closed at 450.66 yuan/gram.

* Metals closed up collectively, LME nickel up 3.59%, LME nickel up 3.18%, LME tin up 3.01%, LME lead up 1.8%. SHFE nickel up 3.40%, SHFE tin up 3.25%, SHFE zinc up 1.97%.

* Commodity futures closed up collectively. Chemistry and energy products saw mixed performance, PTA up 1.41%, EB up 1.12%, polyester fiber up 1.1%. Black series closed up collectively, coking coal up 3.43%, coke up 2.06%, iron ore up 1.68%. Agricultural products performed strong.
