*PBoC: The increase in social financing in July was 528.2 billion yuan, a decrease of 270.3 billion yuan compared to the same period last year. In the first seven months of 2023, The cumulative increase in social financing scale is 22.08 trillion yuan, an increase of 206.9 billion yuan compared to the same period last year.

*PboC: RMB loans increased by 345.9 billion yuan in July, a decrease of 349.8 billion yuan compared to the same period last year.

*PBoC: At the end of July, broad money (in general currency)M2 balance is 2.854 trillion, increase by 10.7% y/y.

Financials

*CSRC agreed to register the Shanghai Export Container Settlement Freight Index (European route) futures and determine it as a specific domestic variety.

*CSRC and the Hong Kong Securities Regulatory Commission reached a consensus on promoting the inclusion of bulk transactions into the interconnection mechanism, which in order to further deepen the mutual access mechanism for trading in the mainland and Hong Kong stock markets, enrich trading methods, enhance transaction convenience, and promote the common development of capital markets in both places.

Industrial Economy

*The US Department of Transport announced on August 11th that starting from September 1st, the number of Chinese passenger flights allowed to fly to the United States will be increased to 18 per week. Starting from October 29th, the number of Chinese passenger flights allowed to fly to the United States will be increased to 24 per week. Currently, this number is 12 shifts per week. *Shanghai recently released the "5G Network Near-Sea Covering and Integration Application" action plan, which proposed that by the end of 2024, the depth and breadth of near-sea coverage and integrated application of 5G networks will be significantly improved, forming a highland for innovative development leading areas, and demonstration areas for intelligent ocean applications empowered by 5G.

* Precious metals closed mixed. COMEX gold contract down 0.16% to closed at \$1945.7/oz. SHFE gold active contract up 0.18% and closed at 455.36 yuan/gram.

* Metals closed down collectively, LME zinc down 2.4%, LME tin down 1.6%, LME zinc down 1.16%. SHFE tin down 1.98%, SHFE zinc down 1.16%, SHFE aluminum down 0.81%.
