Policy

*State Council Premier Li Qiang presided over the executive meeting on October 10th, whichapproved the "Opinions on Strengthening the Dynamic Monitoring of Low-income Population and Doing a Good Job in Social Assistance for Layered Classification", the "Action Plan for Actively Developing Elderly Catering Services" and the "Special Action Plan for Patent Transformation and Application (2023-2025)".

*The Supreme People's Court published the guiding opinions on optimizing the rule of law environment and promoting the development and growth of private economy, which put forward clear requirements for relevant trial execution work, and severely crack down on malicious "rights protection" violations of the legitimate rights and interests of private enterprises in accordance with the law.

Industrial Economy

*The Administration for Financial Regulation recently issued a notice on financial support for recovery and expansion of consumption to local regulatory agencies and various financial institutions, which covers a total of 19 aspects including increasing support for key areas, supporting the expansion of automobile consumption, increasing support for new consumption and service consumer finance, reducing consumer finance costs, strengthening insurance protection services, and effectively protecting the legitimate rights and interests of consumers.

*MIIT and other four departments jointly issued the "Outline of Development of Green Aviation Manufacturing Industry (2023-2035)", which proposed that by 2025, the energy-saving emission reduction and noise reduction performance of domestic civil aircraft will be further improved, the level of green aviation manufacturing will be comprehensively improved, and a safe and effective guarantee system will be basically established.

*HUAWEI aims to ship 60-70 million smartphones in 2024, according to relevant sources, enough orders have been added to the supply chain to ensure that this shipment number can be reached throughout 2024.
