\*MIIT: Continue to promote the implementation of the "Action Plan for the Integration of Virtual Reality and Industry Application Development (2022-2026)", accelerate the large-scale application of virtual reality in key areas such as industrial production and cultural tourism, said by Deputy Minister Xu Xiaolan, at the 2023 World VR Industry Conference.
\*The Administration for Market Regulation recently issued the "Guidelines for Special Food Safety Compliance in Online Sales", which further clarified the responsibilities and obligations of third-party platforms for online food trading and online food operators to sell special food.
\*The Administration for Market Regulation issued the "Guiding Opinions on Measuring Promoting the High-Quality Development of Instrumentation Industry", which pointed out that by 2025, the measurement performance and technical indicators of some domestic instruments and meters will reach or approach the international advanced level.
