*General Office of the State Council issued the "Action plan for solidly promoting high-level opening-up to the outside world to attract and utilize foreign investment", which fully cancel foreign investment access restrictions in the manufacturing sector.

*The State Council Premier Li Qiang recently made important instructions in spring agricultural production, disaster prevention, reduction and relief work, which emphasized to ensure stable production and supply of grains and important agricultural products.

*The Civil Aviation Administration held a meeting on the low-altitude economy of the general aviation work group, which emphasizing to build strategic emerging industries with low-altitude economy, and promoting high-quality development of low-altitude economy.

*Zhengzhou issued a notice on the development plan for electric vehicle charging infrastructure 2024-2035, which pointed out that as of the end of 2025, the city will build 10k public charging facilities.

*National Health Commission: Further improve the children's medical and health service system, require that each province establish a high-level children's specialized hospital or comprehensive hospital for pediatrics.

- * Global crude oil price closed up collectively. May NYMEX crude oil contract up 0.44% to closed at \$82.52/b, May Brent contract up 0.35% to closed at \$87.19/b. INE crude oil active contract up 1.17% to 638.4 yuan/b.
- * Precious metals closed down mostly, COMEX gold active contract down 0.16% and closed at \$2160.9/oz. SHFE gold active contract up 0.06% and closed at 505.98 yuan/gram.
- * Metals closed down mostly, LME tin down 5%, LME nickel down 2.75%, LME copper down 1.29%, SHFE tin down 2.71%, SHFE nickel down 2.35%, stainless steel down 1.09%.
- * Commodity futures closed mixed, coking coal up 2.02%, iron ore up 1.54%, rapeseed meal up 1.42%. No.1 soybeans down 0.82%, white sugar down 0.73%.
